Highlights of Church Church Council Meeting Thursday, March 14, 2024

Roll of Members:

Carol Spiegelberg, Matt Moore, Chris Ziegler, Greg Egner, Kathy Bellaire, Sarah McAninch A. Treasurer's Report- Matt Moore February expenses and payroll exceeded giving by \$3,347.66. This is partially to do with how the last payroll cycle ends in February and slightly elevates the budget. In addition, operating expenses are less since last year and we are blessed to stay current with all accounts. Greg Egner made a motion to approve the financial reports as presented, Chris Ziegler seconded. Motion Passed 6-0

- 1. Congregational Reports –Completed before March 1<sup>st</sup> Matt Moore compiled the financial information required for the report. Carol Spiegelberg coordinated with the church office to make sure the information was gathered and sent to the Synod by the deadline date. Thank you to all.

- 3. Miravida Living Report-Kathy Bellaire shared the news of cardiac and post stroke services being added. She also shared the extraordinary stories and struggles of international nurses working in the states and the determination they have to succeed.

Additional ads could be purchased throughout the year to advertise church activities and news. It was agreed that this ad would serve both Feeding Hungry Kids and the church in the coming months. Greg Egner made a motion to approve the \$500 fee as presented, Kathy Bellaire seconded. Motion Passed 6-0

- -A plow hit the outdoor bench and caused damage. The bench will be repaired
- -4 Classrooms were cleaned and organized (Marcia & Sue)
  - -A cabinet is needed for the literacy group. The committee suggested finding a cabinet already in the building that can be repurposed.

- -Next property meeting is March 28<sup>th</sup> at 9am
- 4. Education –Chris agreed to be contact for education committee going forward. Discussion about working with members from surrounding churches. This would create a larger group to share instruction and activities for adolescent members.
- 5. Worship & Music Kathy Bellaire-Inserts will continue to be placed in pamphlets. Continued use of country specific candles for prayers was discussed. It was decided that candles representing a specific country will no longer be placed in the sanctuary. The WMC will discuss the possibility of offering a special service of prayers for the nations later this year.

A special thank you goes out to the members who provided candles for the remembrance of Ukraine, Israel and Gaza during the year.

### Miravida Living

On March 4th Sirley Guse and I attended the annual meeting of Miravida Living. Theresa Bertram, President and Chief Executive Officer highlighted some of the exciting new ways that Miravida is engaging in new directions as they look toward the future. The corporation has achieved certification in post-cardiac care so that they can be a resource in our community for individuals needing additional care following a heart attack or after cardiac surgery. They are currently working on a certificate for post stroke care with the same goal in mind. The plan to expand the services available to people needing additional care who may not be at a need level where residential care is needed over a long period of time will help Miravida Living to continue to be a vibrant organization into the future. The corporation is also partnering with UWO, UWGB and World Relief Fox Valley to support immigrants and refugees who are interested in becoming health care providers. Miravida Living currently employs 9 individuals from Africa, who work in food service and housekeeping. These employees are hardworking and dedicated and have been an excellent addition to Miravida's team. A young nurse, Adanna Okeke, originally from Kenya shared her story of immigrating to the USA to study at UWO and her joy at becoming a nurse at Bethel Home.

Three new Board members were elected to threeyear terms, Kathy Bellaire, Pastor Jan LaVake and Mary Murkin. The meeting was informative and fun. Thank you for the opportunity to represent St. Andrew's, I am proud that we continue to be a one of the congregations supporting this important mission.

### **Crossways Camp Ministries**

On March 16 Tracy Menchaca and I attended the Crossways Annual Meeting at St. Mark's Church in Neenah. We received an update on Camp Operations for the three camps, Pine Lake Camp in Waupaca, Imago Dei Village, in Clintonville and Waypost Camp in Hatley. We were introduced to members of the camping staff and learned about

the new strategic directions the ministry is moving toward. The most important of these has been the consolidation of some of the administrative duties and sharing of camp staff across the three sites, making it possible to continue to offer a wide range of camping experiences at all three camps. A review of the proposed budget was provided, indicating that Crossways is well positioned to go forward into the new year with confidence. Three members were elected to the Board: Tom Scheuerman from Appleton WI and Rev. Joe Wilkinson who will both be serving a second term, and Laura Welden, from Glendale, WI. joining the Board for the first time. Members of the camps' staff shared inspirational stories from children and adults about how Crossways Ministries has impacted their lives and we got to play a game and learn a song, a fun way to give us a part of the camp experience that greets those who attend. We plan to offer a Temple talk in the near future about what we learned and share information about camping and volunteer opportunities soon. We walked away feeling happy, energized, and optimistic that Crossways will continue to be an integral part of the ELCA ministry for years to come. Kathy Bellaire

**Lutheran Campus Ministries** 

On March 17, Shirly Guse and I attended the annual meeting of the Lutheran Campus Ministries at All Saints Church in Oshkosh. Two individuals were elected to the Board of Directors. Kathy Dutcher and Dave Richards. Pastor Crystal Lee provided an update on the current operations of the ministry on the UWO campus. Currently the Gathering Place has no students coming to The Gathering Place for faith-based activities. The two upstairs apartments are both occupied, and the students living there provide a monthly donation to the program, in addition to bringing others into the house which provides opportunities for interaction with Pastor Crystal. The Board of Directors and Pastor Crystal have determined it is time to move in a different direction. An Ecumenical Partnership with other community churches will be the focus going forward. A partnership with Algoma Blvd United Methodist Church (Pastor Ellen) and Trinity Episcopal Church (Father Chris) is being formed with the goal of pooling resources to provide an inclusive, affirming, faith based and fully ecumenical ministry on the UWO campus that represents the values of mainline protestant churches. The goal is to have this new structure in place for the Fall semester of 2024. The three pastors each provided an overview

of their vision and enthusiastic support of this new direction. The Gathering Place will continue to be the site of operations for this ministry. To that end there are several projects that need attention in the house, a list of volunteer opportunities for anyone interested in getting involved is posted in the narthex. Shirley and I thank you for the opportunity to represent St. Andrew's.
